PLEASE TAKE NOTICE THAT the Township Board of the Charter Township of Bloomfield has declared its intention to make the following improvements:

The repaving (and associated construction items) of the roads within the Wabeek Five Subdivision and Wabeek Six Subdivision; Golf Ridge South, Rockdale Court, Cimarron Court, Moors Court, Brafferton Drive, Ascot Court, Cedar Shake Drive, Golf Ridge East, Cheshire Court, Cimarron Drive, Abby Court, Clubgate Drive, Palmetto Court, Doral Court, Golf Ridge Drive, Canterbury Court, Seminole Court, and Foxfire Court.

The project consists of milling the existing roadbed. A bituminous (asphalt) pavement four (4) inches thick and 22 feet wide will be placed on the conditioned roadbed. A limited amount of drainage improvements will be made to reasonably assure drainage of the pavement. All shoulders and disturbed areas will be covered with topsoil and sod. Existing driveways will be replaced with the same kind of materials that exist to provide a smooth transition from the newly paved roadway.

In addition, the Township Board has designated the special assessment district against which the cost of said improvements is to be assessed as consisting of all lots and parcels of land as set forth above. The tentative special assessment roll can be found on the Township website, <http://www.bloomfieldtp.org/Government/LegalNotices.asp>, and/or at the Township Clerk's office for inspection during regular business hours, Monday through Thursday, 7:00 a.m. – 5:30 p.m.

TAKE FURTHER NOTICE that the Township Board will meet on **MONDAY, MARCH 24, 2014**, at 7:00 P.M. in the BLOOMFIELD TOWNSHIP HALL, 4200 Telegraph Road for the purpose of hearing any objections to the improvements and to confirm the special assessment roll.

In order to appeal the amount of the special assessment to the state tax tribunal, your appearance and protest at the hearing in the special assessment proceeding are required. Appearance and protest may be made by a property owner or party in interest, or his or her agent, in person, or such protest is permitted by letter, without the necessity of a personal appearance.
