This report provides a summary of many arrests, incidents, events and other items of significance occurring in Bloomfield Township. However, it does not include every incident reported to the Police Department. It is possible for publicity to hinder some criminal investigations. In these situations, we do not release information unless it is in the community's best interest or we are certain it will not compromise an investigation.

Summary:

During the timeframe of February 2, 2026, through February 8, 2026, Bloomfield Township Officers handled 519 calls for service, 172 of which were traffic stops.

Traffic Crashes:

Officers investigated 56 total traffic crashes during this timeframe: 38 Property Damage Crashes, 7 Personal Injury Crashes, 3 Hit and Run Crashes, 7 Private Property Crashes, 0 Car vs. Deer Crashes, and 1 Non-UD-10 Crash.

Larceny

6650 Telegraph Road (Planet Fitness)

On February 7, 2026, the Bloomfield Township Police Department took a report of a Larceny from the Planet Fitness located at 6650 Telegraph Road. The victim stated that while at the gym, between 4:00 p.m. and 4:30 p.m., an unknown suspect entered her locker and stole her wallet containing multiple credit cards. MDOP, Retail Fraud, & Possession of Narcotic Equipment

42000 block of Woodward Avenue

On February 5, 2026, the Bloomfield Township Police Department responded to a suspicious circumstance in the 42000 block of Woodward Avenue. An urgent care reported that a male came into the business to warm up and began breaking items in the lobby and the bathroom of the urgent care including putting a hole in the wall. As officers responded to the urgent care they located the suspect, a 30-year-old black male from Detroit. The male suspect was placed under arrest for Malicious Destruction of Property. During a search of his person, officers located \$158.99 worth of stolen merchandise from CVS, a neighboring business to the urgent care. Officers also located narcotic paraphernalia. The suspect was arrested for Malicious Destruction of Property, Retail Fraud, and Possession of Narcotic Equipment. This report was forwarded to the Oakland County Prosecutor's Office to review for charges. The suspect was released pending charges.

42934 Woodward Avenue (CVS)

On February 2, 2026, the Bloomfield Township Police Department took a report of a Retail Fraud from CVS located at 42934 Woodward Avenue. At approximately 2:00 p.m. and unknown black female, approximately 50-years-old stole nine Lumify eyedrops and creams values at \$222.71. The female selected the items and concealed them in her purse before leaving the store. CVS provided officers with video surveillance of the incident.
