NOTICE OF REGISTRATION
FOR THE STATE PRIMARY ELECTION TO BE HELD ON
TUESDAY, AUGUST 4, 2020

To the qualified electors of the CHARTER TOWNSHIP OF BLOOMFIELD, County of Oakland:

PLEASE TAKE NOTICE that any qualified elector of Bloomfield Township who is not already registered may register to vote at the Bloomfield Township Clerk's Office, the office of the County Clerk, a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at www.mi.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, July 20, 2020**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Bloomfield Township Clerk's Office, located at 4200 Telegraph, Bloomfield Hills, MI, 48302 at the following times:

- Regular business hours: Monday – Thursday from 7:00 a.m. to 5:30 p.m.
- Friday, July 24, 2020, from 10:00 a.m. to 4:00 p.m.
- Friday, July 31, 2020, from 10:00 a.m. to 5:00 p.m.
- Saturday, August 1, 2020, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, August 4, 2020, from 7:00 a.m. to 8:00 p.m.

The election will be conducted in all voting precincts of the Charter Township of Bloomfield for the purpose of **nominating** candidates for the following offices:

CONGRESSIONAL	U.S. Senator, Representative in Congress
LEGISLATIVE	Representative in State Legislature
COUNTY	County Executive, Prosecuting Attorney, Sheriff, Clerk/Register of Deeds, Treasurer, Water Resources Commissioner and County Commissioner
TOWNSHIP	Supervisor, Clerk, Treasurer, Trustees
NONPARTISAN	Judge of Circuit Court, 6 th Circuit Court, Non-Incumbent Position

Precinct Delegates to the County Convention of the Republican and Democratic parties

And to vote on the following ballot proposal for voters in the Bloomfield Hills School District:
