LETTER FROM THE CHIEF CHIEF JAMES GALLAGHER



I am proud to present the 2022 annual report. I would like to thank the residents of our community for supporting and passing the Public Safety Millage in August 2022. We are truly grateful for the support.

On July 1, 2022, I was promoted to Chief of Police due to the retirement of Chief Phil Langmeyer. Chief Langmeyer retired after serving Bloomfield Township for over 30 years. Chief Langmeyer led our department through some of the most challenging events in our profession's history. From COVID 19 to civil unrest, Chief Langmeyer vowed that the men and women of the Bloomfield Township Police Department would be leaders in serving our residents and visitors reflecting our core values of integrity, respect, fairness, pride and accountability. Under his leadership, our police family delivered on his promise. Chief Langmeyer accepted the Police Department's accreditation in 2019 and helped develop our mental health Co-Responder (CoRE) program in partnership with Birmingham and Auburn Hills. On behalf of the Bloomfield Township Police Department, I would like to thank Chief Langmeyer for his leadership, dedication, friendship and service to the residents and our employees.

We completed our first full year with our mental health Co-Responder program and clinician Hillary Nusbaum. There were 664 cases referred to Hillary from all three agencies: 239 referrals from Bloomfield Township. The Co-Responder program has been used as a model and the program has been implemented by the Oakland County Sheriff's Office and the City of Troy Police Department. In September, we were awarded a federal grant of \$260,000 to expand our CoRE team by adding the City of Rochester Police Department and hiring a second clinician to handle the caseload. The CoRE program is truly an asset to our community.

We continued the transition within the police department with the retirements of over 200 years of combined service including the Chief of Police, three lieutenants, two detectives, one dispatcher, and a Village Officer. We hired five officers, two dispatchers, and one Animal Welfare Officer.

We look forward to the exciting challenges and successes of 2023. We will continue to see more staff retire. We will focus on developing leaders at all levels of the agency. We will continue to partner with our Community Cable, Elected Officials, and community to recruit and retain the best of the best to serve our community. We will look for new opportunities and partnerships to increase our effectiveness and efficiency to our community.

I am honored to lead the great men and women of the Bloomfield Township Police Department into the future. I am forever grateful to my predecessors for their mentorship and trust to be the Chief of Police. Thank you to our residents, employees, Elected Officials, and Township Trustees for your continued support of your Police Department.

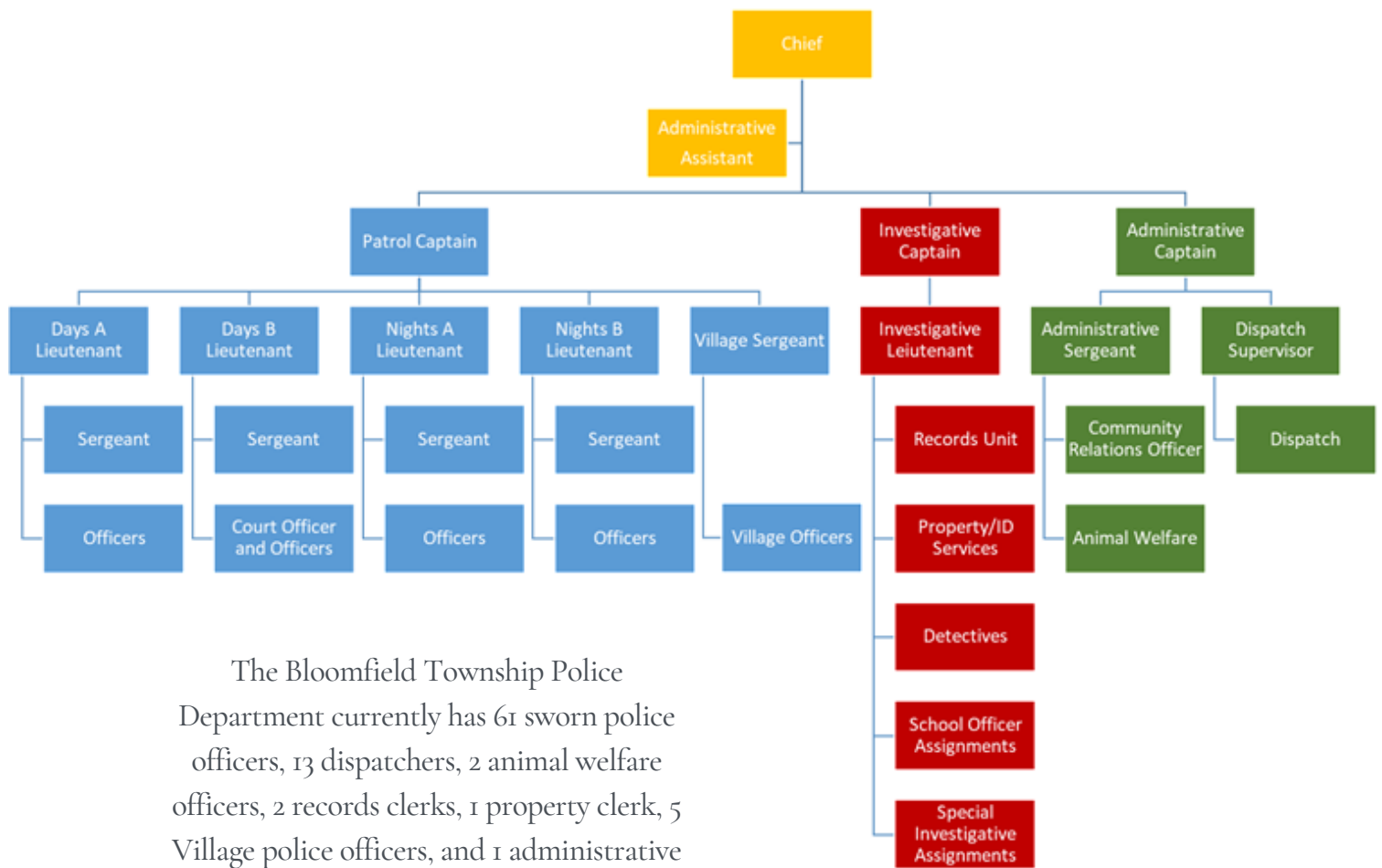

ACCOMPLISHED

This year, Lieutenant Dan Brown graduated from the School of Staff and Command, a 400-hour problem-based learning (PBL) course conducted by Michigan State University's Center for Police Executive Development. Its purpose is to develop the next generation of police command officers. Students are presented with problems facing law enforcement executives and asked to come up with real-life solutions. Students collaborate in small groups with an instructor/facilitator guiding and mentoring them. They learn to solve problems through in-depth discussion and critical thinking exercises with each scenario becoming increasingly more complex. Every student is asked to identify an issue facing their department, and design a workable solution that can be implemented upon their return.

The course includes on-site classroom instruction and distance learning. Distance learning requires students to commit 40 hours per week, being available between the hours of 8am and 5pm.

25,883 CALLS FOR SERVICE

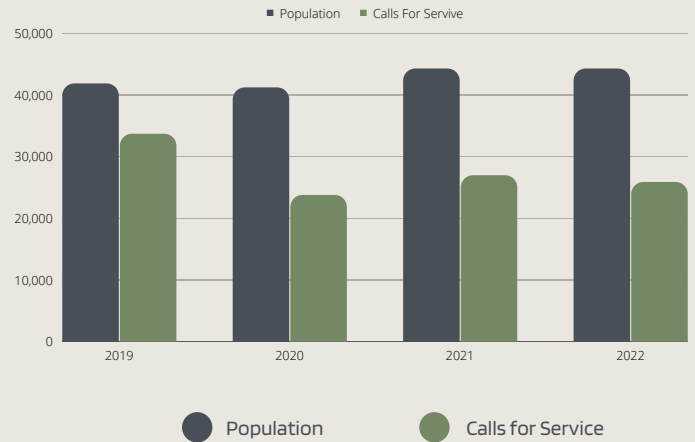
In 2022, the department handled 25,883 Calls For Service (CFS). A CFS is a record of police service or activity. Examples include a phone call into dispatch requesting police assistance or a police officer affecting a traffic stop. Likewise, a CFS is created when an alarm company calls the department to report one of its alarms have tripped.

The Bloomfield Township Police Department prides itself on Service Oriented Policing. Service Oriented Policing is an integration of a police agency with its community. Through an interactive partnership with the community, a greater percentage of crimes can be solved, and the public safety concerns of the residents can be addressed.

The Police Department offers a number of community-care taking services, such as:

- **Vacation House Checks:** When a resident leaves their home for an extended period of time, they are encouraged to contact us, providing their dates of departure and return, and emergency contact information. In addition, we will check your home on a regular basis while you're away.
- **Vehicle Lockouts:** It's frustrating and we've all done it. The Bloomfield Township Police Department still assists motorists who've found themselves in this situation.
- **School Security Checks:** It's not unusual to find our officers doing a walk through the schools in Bloomfield Township.

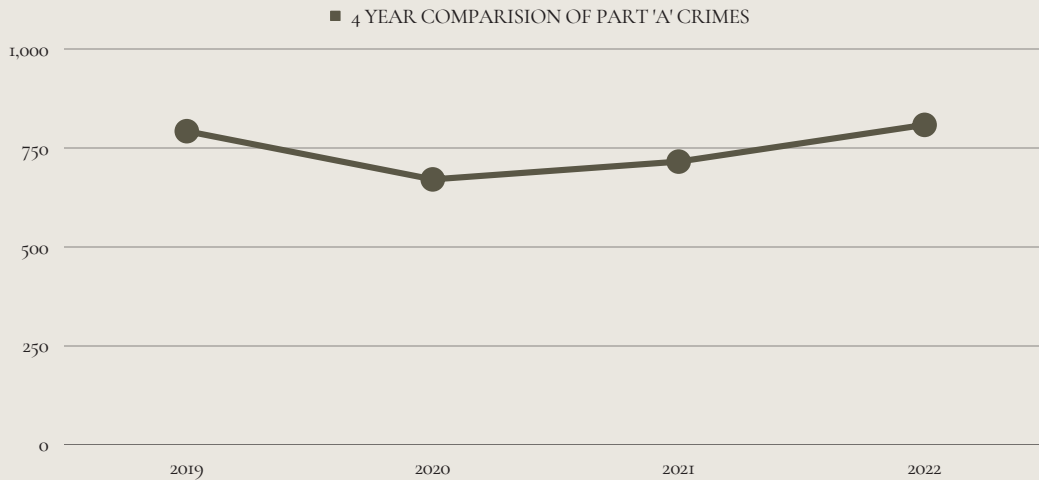

Bloomfield Township investigated 809 Part 'A' Crimes in 2022.

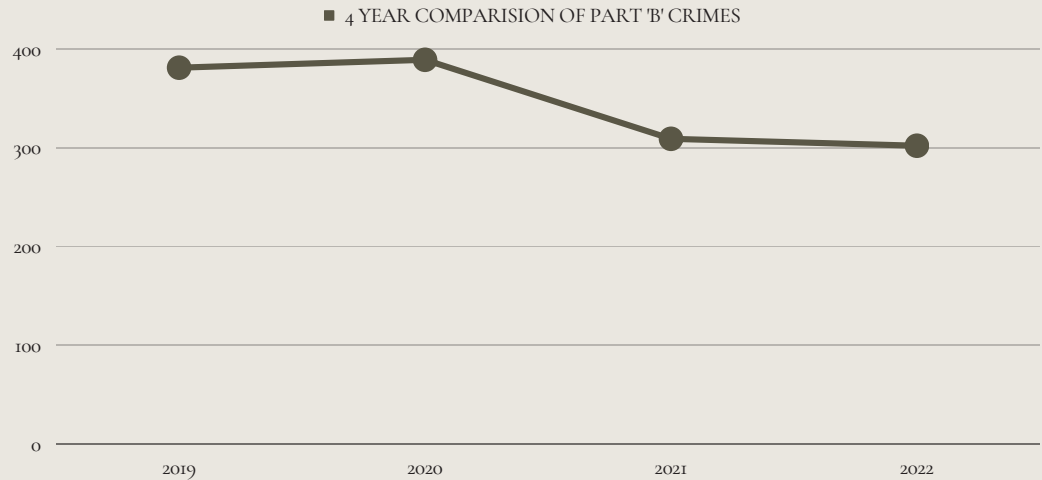

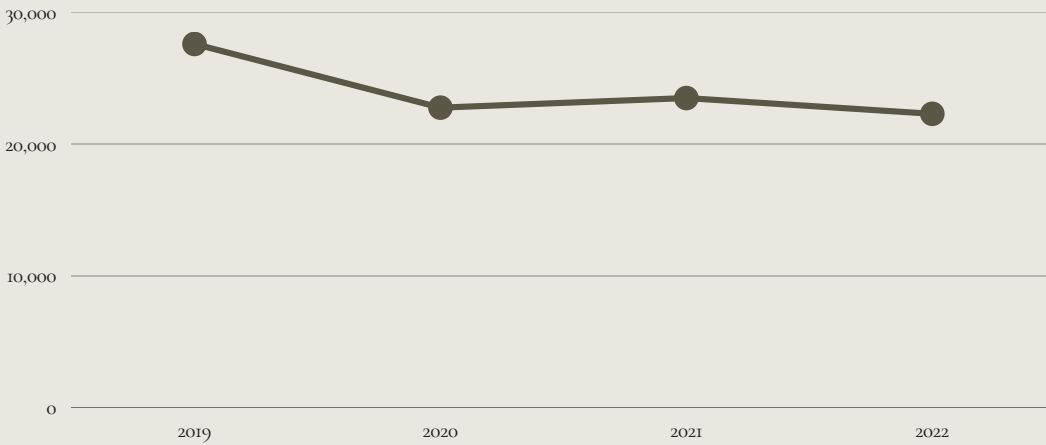

Part 'C' Complaints can be relatively minor misdemeanors, but are also very common Calls For Service (CFS). For instance, the Part C offense of "Crash" indicates that one of the drivers was issued a civil infraction citation (ticket) for the traffic crash.

PATROL

When someone calls, they expect professional police response in a timely manner. Patrol is the largest division in the department, consisting of 36 uniformed officers, 8 supervisors, and two K-9 teams. Patrol personnel are organized into four platoons, providing around-the-clock police service. While the men and women of the Patrol Division do a great job, they continuously strive to improve the delivery of services to the community.

BLOOMFIELD VILLAGE

The Bloomfield Village Police Station is located at 3595 Bradway Blvd. in Bloomfield Village, MI. Bloomfield Village Police Officers may be contacted by calling the dispatch at 248-433-7755, or in an emergency, 911.

The Bloomfield Village Police Department is funded through a special assessment on Bloomfield Village residents. Village police officers are sworn law enforcement officers under authority of the Bloomfield Township Police Department.

The Bloomfield Village Police Department is a directed patrol unit of the Bloomfield Township Police Department. The Bloomfield Village Association contracts with Bloomfield Township Police to hire experienced Police Officers. These officers are then assigned to patrol areas within Bloomfield Village.

Bloomfield Village officers maintain an increased police presence within the village limits and their primary duty is to respond to calls for service from its residents.

Village officers assist Township officers when needed in other areas of Bloomfield Township.

INVESTIGATIONS



The mission of the Investigations Division is to identify, target, arrest and successfully prosecute individuals involved in criminal activity as well as recover stolen property. The Investigations Division is managed by a lieutenant who oversees the investigations, assigns cases and handles day-to-day operations. There are five Detectives in the Investigations Division as well as two school related positions, School Liaison Officer (SLO) and the School Security Officer (SSO).

The Detectives establish and maintain liaisons with other law enforcement agencies, State and District Attorney's Offices as well as the local State and District courts. The Detectives participate in all forms of investigative activities including conducting surveillance, obtaining and serving arrest warrants, search warrants, probation, and parole searches. Detectives also monitor and verify compliance with registered sex offenders.

Detectives are carefully selected for the Investigations Division based on experience, work ethic, and the ability to conduct in-depth criminal investigations. They investigate complex and demanding cases, which could take months, sometimes years, to fully investigate. Our Detectives develop an advanced level of expertise by attending specialized training and working complex cases with colleagues at the local, state, and federal levels.

SPECIAL UNITS

SPECIAL INVESTIGATIONS UNIT

The Troy Special Investigations Unit (SIU) is a task force of police officers from Bloomfield Township, Troy, Auburn Hills, Royal Oak, and Birmingham. The SIU focuses on crimes committed within these communities and working closely with detectives from each department identifying suspects and assisting in solving cases.

Cases Investigated by Troy SIU include:

- Larceny from Auto -Stolen Property
- Home Invasions -Retail Frauds -Bank Robbery -Felonious Assaults -Larceny in Buildings -Terroristic Threats -Prescription Fraud -Parole Violations -Homicide
- Narcotics -Breaking and Entering -Stolen Vehicles

NARCOTIC ENFORCEMENT TEAM

Since 2001, the Oakland County Sheriff's Office has led the Oakland County Narcotics Enforcement Team (N.E.T.) with a highly cooperative working relationship with several federal and local police departments. This year, the N.E.T. unit worked closely with the Drug Enforcement Agency (D.E.A.) to successfully disrupt and dismantle drug trafficking organizations.

In the course of their investigations, task force agents / officers prepare various types of warrants, conduct surveillance, make arrests, interview suspects and witnesses, and execute search warrants. Occasionally, property and money may be seized and forfeited, as allowed by law.

After completing their tour with the task force, our officers return to their patrol duties with experience and investigative insight that few in law enforcement will ever have. Further, they have discovered the enormous resources available to local law enforcement agencies like the Bloomfield Township Police Department, resources that can all be used to better serve and protect the community.



FBI VIOLENT CRIMES TASK FORCE

The task force investigates federal crimes that occur in, or originate from Oakland County. Some of these crimes include drug and firearms trafficking, bank robbery, other armed robberies, conspiracy, and harboring fugitives. The task force assists local agencies' investigations, especially those involving missing / abducted children.



FBI IDENTITY THEFT & FRAUD TASK FORCE

Identity theft and fraud-related crimes are the fastest growing crimes in the United States. The primary reason is such crimes typically offer very high reward with very low risk. Given those conditions, even traditional gangs are becoming involved.

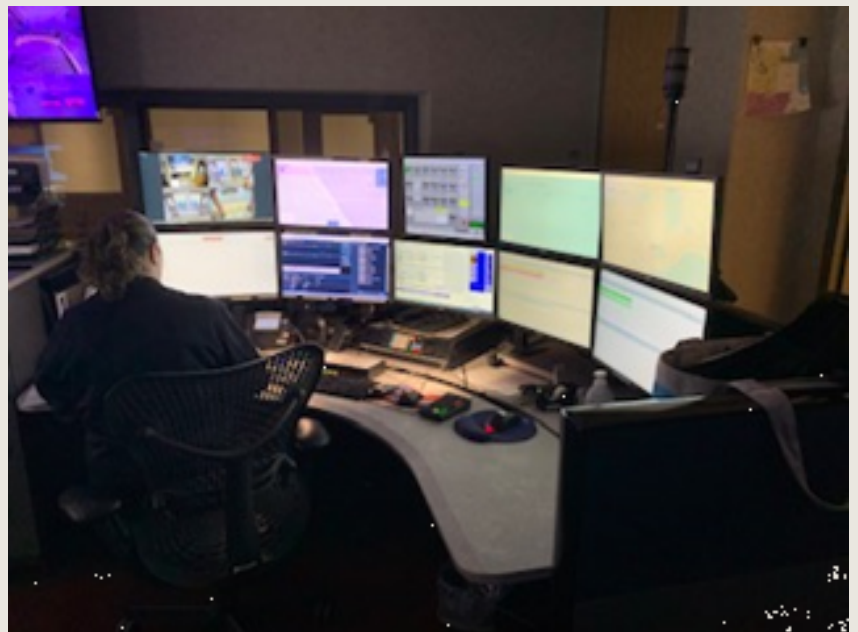
Bloomfield Township's 911 Dispatch Center, also known as a Public Safety Access Point (PSAP), receives incoming emergency and non-emergency phone calls and dispatches the appropriate services to that location (police, fire, and EMS).

The center is equipped with the latest emergency telecommunications technology, including Enhanced 9-1-1 and Computer Aided Dispatch (CAD). Together, the location and phone number of a caller is displayed on a map, as well as fire and police assets. This assures the most efficient delivery of services.

Dispatch operates 24 hours a day and consists of 12 Dispatchers distributed over 4 shifts and 1 Dispatch Supervisor. All communications personnel receive extensive training related to emergency and non-emergency operations. Bloomfield Township dispatches Fire, Bloomfield Township Police, and Franklin Village Police

In addition to their duties, dispatchers also monitor the radio traffic of several agencies, including the Michigan State Police, Oakland County Sheriff, and area fire departments. Dispatchers also send and receive information through the Law Enforcement Information Network (LEIN) and the National Crime Information Communications (NCIC) network.

RECORDS AND PROPERTY

The Records Division handles much more than just reports. In addition to processing Freedom of Information Act (F.O.I.A.) requests, the Records Division has several other responsibilities.

The Records Division also works closely with the Detective Bureau to ensure registered sex offenders are in compliance with the MI Sex Offender Registry.

Amongst all those duties, they also issue and record handgun registrations. In 2022, our department registered 919 handguns to residents.

Due to frequent changes in the laws, policies and procedures are updated in these practices frequently. It is the responsibility of the Evidence/Property Clerk to stay current on evolving trends in legal processes involving evidence and property.

NEW HIRES

No one is born a great police officer; they're trained. When we hire a new officer fresh from the police academy or a veteran from another department, they all go through the Field Training Officer Program (FTO). The 16-week program consists of 12 very experienced officers tasked with training the department's next generation, each dedicated to mentoring and developing the new recruit to the department's standards.

How does one become a Bloomfield Township Police Officer? Firstly, all of our officers must possess a bachelor's degree from an accredited college or university at the time of application. Then, the candidate must successfully graduate from a state certified police academy. After psychological and medical testing and being hired, a recruit officer's first two weeks of employment consist of in-house training. This training includes firearms, report writing, radio communications, policies and procedures, defensive tactics, and much more.

At the conclusion of this two-week training, new officers receive their badge and are sworn in by the Township Clerk. They are then assigned to a Primary FTO who will begin their rigorous and comprehensive 4-month field training program. Every day of this program, their performance is evaluated by their FTO and once a week, by a supervisor. Chances are this new officer has never faced such day-to-day scrutiny in their life.

The FTO program consists of four phases of training, each phase approximately four weeks long. The new officer will be required to work different shifts under the guidance of several FTO's.

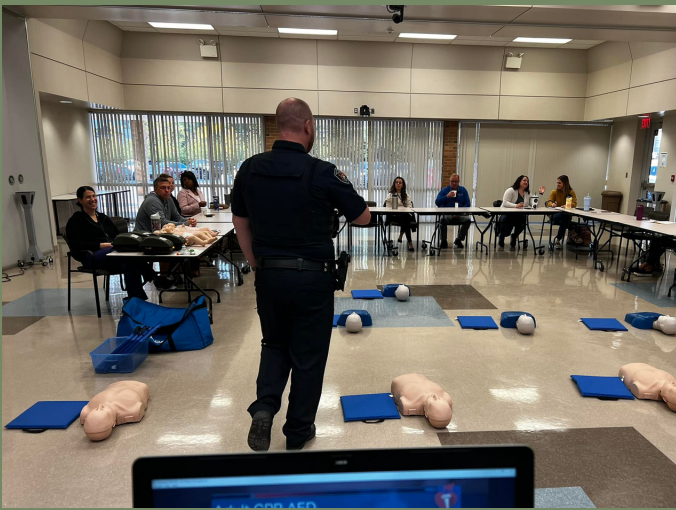
